Voyager Village wants trails gated now. Buck will work with Steve Johnson @ Voyager Village to get specifics and when the gates can be installed.

A new lake marker was presented at the club by Greg Brady and Buck would like to use on a trial basis on Big McKenzie Lake. Cost for these markers range from \$8.50-\$12.00 per marker. They are a tall plastic orange pole that the club would put reflective tape on them and they float if unable to retrieve from lakes before the ice melts.

Dave Cloutier made a motion: purchase \$500.00 worth of the new markers and try them, 2nd by Larry, motion carried

There is wash-out on trail 8 on Lake 26 – ATV club took care of this.

Dave Cloutier stated there are a couple spots on trails 8 & 41 (North of Namekagon) where 4-wheelers tore up the trail. He would like to use a bobcat to flatten out and repair the damage. Tina made a motion: to allow Dave Cloutier to get someone to come in and take burrs out (flatten) on trails 8 & 41 due to ATV's not to exceed \$500.00, 2nd by Scott, motion carried.

He also wants to put in a couple posts by Voyager Village and he will discuss this with Steve Johnson @ Voyager Village on specifics.
